Owner understands that each bird placed with FEBS must undergo a thorough medical examination by a qualified avian veterinarian prior to final acceptance for permanent residence at the sanctuary. If the exam for the bird(s) subject to this Agreement is to be arranged by FEBS, Owner agrees to pay FEBS the then prevailing medical examination fee per bird in addition to whatever sponsorship donation may still be due at time of permanent placement.

Owner agrees to periodically notify FEBS via phone call, text message, email or USPS mail regarding the status of the subject bird(s) and Owner's then current situation. To the extent amenable to the circumstances of the future moment, Owner agrees to provide at least two weeks' notice to FEBS of the planned date for delivery of the bird(s) to the sanctuary for intake processing. Owner understands and agrees that, should Owner wish to have FEBS retrieve the bird(s) from Owner's residence for transport back to the sanctuary, Owner will be responsible for paying FEBS the reasonable costs associated with such transport.
